ORDER RESETTING DEADLINES AND CASE MANAGEMENT CONFERENCE

THIS MATTER came before the Court on March 1, 2013 at 3:00 p.m. upon the *Order Setting Case Management Conference* (the "Case Management Order") entered on January 25, 2013 and the *ore tenus* motion of counsel for the Conservator for an extension of time to serve process upon certain of the defendants. The Court having reviewed the First Report of Conservator, having heard argument and proffer of counsel, finding good cause for granting the relief requested, and for the reasons stated on the record, it is

ORDERED and **ADJUDGED** as follows:

1. The Initial Case Management Conference is reset for a period of approximately ninety (90) days to ~~May 31~~, 2013 at ~~1:30 a.m.~~ ^{JUNE 7, 1:30} p.m. All deadlines set by the Case Management Order are extended accordingly.

2. Pursuant to Fla. R. Civ. P. 1.070(j), the time for timely service of initial process is extended through and including April 30, 2013. On or before April 30, 2013, Philip von Kahle, the court-appointed Conservator¹ (the "Conservator"), shall serve initial process upon the

¹ On January 17, 2013, this Court appointed Philip von Kahle as Conservator of the plaintiffs, P&S Associates, General Partnership and S&P Associates, General Partnership (the "Partnerships") in that certain related case styled *Matthew Carone, as Trustee for the Carone Marital Trust #2 UTD 1/26/00, et al. v. Michael Sullivan*, Case no. 12-24051 (7), pending in the Circuit Court of the Seventeenth Judicial Circuit, in and for Broward County, Florida. Through such appointment, the Conservator is vested with, among other things, authority to advance this action.

defendants or shall file a motion with this court requesting an additional extension and showing good cause why such extension ought to be permitted.

3. On or before May 31, 2013, the Conservator shall file a Distribution Report including his recommendation and analysis as to how distributions ought to be made to the general partners of each of the respective Partnerships.

4. On or before June 30, 2013, interested parties shall file responses, if any, to the Conservator's Distribution Report.

5. On or before August 28, 2013, the Conservator shall file a motion seeking approval of a scheme of distribution to the general partners of each respective Partnership.
