ORDER RESETTING DEADLINES AND CASE MANAGEMENT CONFERENCE

THIS MATTER came before the Court on March 1, 2013 at 3:00 p.m. upon the *Order Setting Case Management Conference* (the "Case Management Order") entered on January 17, 2013. The Court having reviewed the First Report of Conservator, having heard argument and proffer of counsel, for the reasons stated on the record, it is

ORDERED and **ADJUDGED** as follows:

1. The Initial Case Management Conference is reset to ~~May 31~~, 2013 at ~~1:30~~ ^{June 7,} ~~am~~ ^{1:30} ~~pm~~ /

(p.m.) All deadlines set by the Case Management Order are extended accordingly.

2. On or before April 1, 2013, the Conservator shall file a Fee Report: (i) detailing the fee applications he received by the various professionals who purported to incur fees and costs on behalf of P&S Associates, General Partnership and/or S&P Associates, General Partnership (the "Partnerships") prior to the entry of this Court's January 17, 2013 Order

Appointing Conservator (the "Fee Applications"); (ii) analyzing whether the fees and costs of each Fee Application are properly chargeable to the Partnerships; and (iii) analyzing whether the fees and costs requested through the Fee Applications are reasonable.

3. On or before May 31, 2013, the Conservator shall file a Litigation Status Report advising the Court as to whether the Conservator has determined that advancing litigation on behalf of the Partnerships is reasonable and, if so, proposing counsel to represent the Conservator in such law suits.
