CONSERVATOR'S REPORT OF UNSERVED DEFENDANTS

Philip J. von Kahle (the "Conservator"), as Conservator for P&S Associates, General Partnership ("P&S") and S&P Associates, General Partnership ("S&P") (together, the "Partnerships"), by and through undersigned counsel, hereby files the *Conservator's Report of Unserved Defendants*, and states as follows:

1. To date, after expending considerable efforts to locate and serve all parties-in-interest in the above-styled lawsuit, approximately thirty Defendants remain unserved (the "Unserved Defendants").
2. Of the Unserved Defendant, it has been confirmed that twenty-three of the thirty are deceased.¹ The Plaintiff has not been able to locate their beneficiaries, if any.
3. Of the Unserved Defendants, only two, Matthew and Elizabeth, are entitled to a distribution. The Conservator is holding funds of approximately \$4,005.79, until either: (i) the defendant contacts the Conservator or; (ii) further Court Order.

4. The final six Unserved Defendants: Holy Ghost Fathers HG- Mombasa, Kathryn Silecchia, Marilla Da Silva, Rita Marema, Evelyn S. Millman, and Projeto Esperanca de Sao Miguel Paulista, are Net Winners and are not entitled to receive a distribution.

5. The Conservator has made diligent efforts to serve the Unserved Defendants. The Conservator has determined, in his business judgment that continuing to expend resources on service attempts is not in the best interests of the Partnerships.
