STIPULATION BETWEEN THE CONSERVATOR AND SCOTT HOLLOWAY¹

Philip J. von Kahle (the "Conservator"), as Conservator for P&S Associates, General Partnership ("P&S") and S&P Associates, General Partnership ("S&P") (together, the "Partnerships") and Scott Holloway and Scott W. Holloway Revocable Trust (collectively "Holloway", and together with the Conservator, the "Parties"), through their undersigned counsel, hereby stipulate and agree as follows (the "Stipulation"):

1. In the Distribution Motion, the Conservator provided a calculation of Holloway's Net Investment claim amount. Holloway disputes this amount.
2. In the interest of conserving the parties' and the Court's resources, the Conservator and Holloway have agreed to enter into this Stipulation.
3. The Parties agree to continue Court determination of certain issues between the Conservator and Holloway to allow the Parties the opportunity to evaluate their positions and seek resolution without further litigation.
4. This Stipulation is without prejudice to the Parties' ability to advance their respective positions upon appropriate motion.


