3. The court record is exempt from public access on the grounds to
 prevent a serious and imminent threat to the fair, impartial, and orderly administration of justice
 protect trade secrets
 protect a compelling governmental interest
 obtain evidence to determine legal issues in a case

- avoid substantial injury to innocent third parties
- avoid substantial injury to a party by disclosure of matters protected by a common law or privacy right not generally inherent in the specific type of proceeding sought to be closed
- comply with established public policy set forth in the Florida or United States Constitution or statutes or Florida rules or case law

4. A party's name is confidential and the pseudonym available to the public is _____ / is not confidential.
5. The progress docket or similar records generated to document activity in the case is exempt from public access / is not exempt from public access.
6. The following civil court record is exempt from public access:
Plaintiffs' Response to Defendant Michael D. Sullivan's Motion to Enforce Settlement/Dismiss; Exhibit A to Plaintiffs' Response to Defendant Michael D. Sullivan's Motion to Enforce Settlement/Dismiss.
7. The exempt civil court record may be viewed by: The Parties to the Court's Confidentiality Order.
8. The degree, duration, and manner of exempting the civil court record from public access is no broader than necessary and there is no less restrictive measure to protect the interests of the party and public.
9. The Clerk of Court shall post a copy of this order on his website within ten (10) days of this order and it shall remain posted for a period of at least thirty (30) days.
10. The Clerk of Court shall post a copy of this order in a prominent, public location at the courthouse within ten (10) days of this order and it shall remain posted for a period of at least thirty (30) days.
