**CONSERVATOR'S UNOPPOSED MOTION TO EXTEND TIME TO
FILE A JOINT PRE-TRIAL STIPULATION**

Philip J. Von Kahle (the "Conservator"), as Conservator for P&S Associates, General Partnership ("P&S") and S&P Associates, General Partnership ("S&P") (together, the "Partnerships"), files the *Conservator's Unopposed Motion to Extend Time to File a Joint Pre-Trial Stipulation* (the "Motion"), and in support thereof states as follows:

1. On October 11, 2013 this Court entered its *Scheduling Order for November 19, 2013 Trial* (the "Scheduling Order").
2. The Scheduling Order provides, among other things, that the deadline for the parties to prepare and file a joint pre-trial stipulation is October 21, 2013.
3. The final pre-trial conference is scheduled for October 30, 2013 (the "Pre-Trial Conference").
4. The Conservator and certain parties have worked diligently to prepare the joint pre-trial stipulation.

5. The Conservator believes that an extension of time is appropriate to allow the parties an opportunity to further narrow the issues to be determined by the Court at trial.

6. The Conservator is not aware of any objections to the relief sought in this Motion.

7. Accordingly, the Court ought to extend the time to file a joint pre-trial stipulation through and including October 28, 2013.

WHEREFORE, the Conservator requests that the Court enter an Order extending the deadline to file a joint pre-trial stipulation through and including October 28, 2013, and granting such other relief as the Court deems just and proper.
