# ORDER APPROVING CONSERVATOR'S APPLICATION FOR ALLOWANCE AND PAYMENT OF COMPENSATION AND REIMBURSEMENT OF EXPENSES FOR ROSENBAUM SOBEL, LLC AS ACCOUNTANTS

The Court, having considered the entire record in this case, including, among other things, the Application, noting that due and adequate notice has been given to all parties-in-interest and no further or other notice is required, and after due deliberation and sufficient cause appearing for same, this Court finds it appropriate to approve the Application and relief requested therein.

Accordingly, it is hereby **ORDERED** and **ADJUDGED** as follows:

- 1. The Application is **APPROVED**.
- Conservator is hereby authorized to pay Rosenbaum the sum of \$8,089.75 in payment of reasonable fees accrued during the Accountant Application Period, out of the Partnerships' assets, allocated between the Partnerships on a reasonable basis
